

# Editorial

The present special issue of the European Journal of Law Reform on bonum commune has its early roots in a symposium organized by the Swiss Academy of Humanities and Social Sciences on famous Monte Verità, the ‘mountain of truth’, above Ascona on Lago Maggiore in 1996. While the participants at that symposium reflected on human beings as egotists, the idea for another symposium was born, one to deal with the common good or *bonum commune*.

After long and careful preparations, Professor Beat Sitter-Liver, on behalf of the Swiss Academy, invited a group of scholars from diverse disciplinary backgrounds, to spend a week in the Swiss mountains in November 2003, this time at the Gerzensee Centre of the Swiss National Bank. In particular thanks to the careful selection of opinionated individuals and the open format of the discussions, this symposium turned out to be an eye-opener in many respects and an experience that none of the participants will easily forget.

As a result of the 2003 symposium, the Swiss Academy published a volume entitled *Gemeinwohl – Bien commun: Ein kritisches Plädoyer – Un plaidoyer critique* (Academic Press Fribourg 2004). That book unites nineteen position papers from the participants of the symposium, fifteen in German language, three in French and one in English.<sup>1</sup> To make at least some of the
